

**Daviess County Council Meeting  
Minutes  
April 11, 2018**


The Daviess County Council met Wednesday, April 11, 2018 at 9:00 A.M. in the Commissioners' Room of the Daviess County Courthouse.

 **Roll Call.**

President Mike Myers called the meeting to order.

**MINUTES OF THE MARCH 14, 2018 MEETING**

**BUDGET HEARING AND ADOPTION DATES**

Patty Ball, Daviess County Auditor, asked the Council to set the Budget Hearing and Budget Adoption dates. Mrs. Ball told the Council that she suggests August 22<sup>nd</sup> 2018 for Budget Hearings and September 12<sup>th</sup> and 13<sup>th</sup> 2018 for Budget Adoptions. The Council had no opposition to those dates.

**COMBINED DISPATCH COST ANALYSIS**

Mr. Myers stated that there have been some talks about a combined dispatch with the City of Washington again. He has spoken to the City's Mayor and Jason Semler with Umbaugh about doing a cost analysis for this and splitting the cost with the City of Washington. Mr. Myers added that Posey, Warrick, and Vanderburgh Counties have combined their dispatches. He noted that Posey County has done it recently and is the closest. Vigo County is coming to the April 27, 2018 Commissioners' meeting to speak about this. Mr. Sprinkle stated that he feels talking to these counties and getting information and data from them is a suitable solution. He prefers going this route instead of paying an estimated \$25,000 for a cost analysis. Mr. Norris stated that the \$25,000 is higher than what they anticipated, so he feels the county does not need to have the cost analysis done at this time. Mr. Myers stated that he would contact Umbaugh and Mayor Wellman and let them know that the county is no longer interested in pursuing a cost analysis.

## JAIL-REPAIR & MAINTENANCE


Dale Quakenbush, IT Director, stated that this appropriation request is for new security cameras and equipment at the jail, as discussed in previous meetings. It has gone through the bid process, and last night the Commissioners awarded a bid for \$346,000 from Security Automation Systems out of Indianapolis. He stated that this bid is to replace everything, cameras, audio, new cables, etc. It also has a 3 year warranty. Mr. Norris stated that it is more money than originally expected, but the county is getting a lot more. This will meet all the requirements of the Prosecutor and should last about 20 years. Mr. Quakenbush stated that he will get a quote from SAS for the new annex too. This will allow us to all be on the same system. This contract allows for 200 days of stored footage. Mr. Quakenbush stated that there is no yearly maintenance contract. The county would just pay for anything that may break after the 3 year warranty is expired.




