**UMBAUGH INVOICE-PATTY BALL**

Patty Ball, Daviess County Auditor, stated that H. J. Umbaugh & Associates sent an invoice for professional services on the TIF annual report and meeting with the Redevelopment Commission. Jason Semler with Umbaugh thought this was to be paid out of EDIT funds, however, Mrs. Ball stated that historically it has always been paid out of the corresponding TIF funds. Mrs. Ball stated that the GPC TIF fund is currently depleted due to paying off the 1999 GPC bond. Mrs. Ball suggested paying ½ of this \$6,725.00 out of the Westgate TIF and ½ out of the EDIT fund.
