ORDINANCE 2022 - 4

AN ORDINANCE ADOPTING THE 2023 BUDGET OF THE TOWN OF ELNORA,
DAVIESS COUNTY, INDIANA

WHEREAS, the Town Council of the Town of Elnora, Daviess County, Indiana is comprised of a majority of Volunteer Firefighters; and

WHEREAS, Ind. Code 36-1-23-2 states that the volunteer firefighters must abstain from voting on the Town's budget; and

WHEREAS, the Daviess County Council, as the fiscal body of Daviess County, Indiana, held a public hearing on the proposed budget of the Town of Elnora, Daviess County, Indiana on September 28, 2022.

THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF DAVIESS COUNTY, INDIANA, that the Budget of the Town of Elnora, Daviess County, Indiana is hereby ADOPTED as submitted:

Notice is hereby given to taxpayers of **ELNORA CIVIL TOWN, Daviess County, Indiana** that the proper officers of **ELNORA CIVIL TOWN** will conduct a public hearing on the year **2023** budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of **ELNORA CIVIL TOWN** not more than seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate, or tax levy to which taxpayers object. If a petition is filed, **ELNORA CIVIL TOWN** shall adopt with the budget a finding concerning the objections in the petition and testimony presented. Following the aforementioned hearing, the proper officers of **ELNORA CIVIL TOWN** will meet to adopt the following budget:
